## SCHOLARSHIP PROGRAM CHANGES

Since 2007 I have been the Scholarship Program Director and our chapter has awarded 67 scholarships, totaling \$102,250.00 since the inception of the program in 2005. I want to thank all the members who have supported this program. Recently Scholarship America, who administered the program, has reorganized and they will no longer be involved in helping us with the selections. Because of this, the Board has decided to form a Scholarship Committee to administer our program and develop an application. The Committee will be headed by Brad McCullough and the members are Joanne Clum, Tricia King, Adrian D'Souza and myself.

The Committee will be developing the selection criteria, which will probably be like past criteria. You will want to watch our newsletters and website for a new scholarship application and updates. We anticipate that the awards will be based on academic merit and ability, as well as extra-curricular activities. We suggest that you encourage your children, grandchildren, or great-grandchildren to apply for one of the scholarships once the new process is announced.

Requirements for eligibility remain the same at this time: Students may apply each year they are eligible, but those who have previously been awarded a scholarship by our organization are not eligible to reapply. The criteria for eligibility are:

- Be a child, grandchild or great grandchild of a dues paying member of the chapter.
- Be age 25 and under.
- Be enrolled, or plan to be enrolled, in the coming school year in a full-time undergraduate course of study at an accredited two or four-year college or university.

At this time, the applications deadline for academic year 2021-2022 will probably be May 2, 2021 but that could be adjusted. Please watch our newsletters and website to see if the date changes and for process changes. The Chapter application will be available on the website once it is developed, which we anticipate will be in the new year.

Again, I want to thank you all for your support. It has been my pleasure to be involved with our scholarship program and I am proud of all the successful recipients that have been chosen, as well as the support our members have shown with your donations.

# **CRA NATIONAL PUBLICATIONS**

**Oct. 5, 2020** - Chevron Corporation announced today that its acquisition of Noble Energy, Inc. (NASDAQ: NBL) has been completed following approval by Noble Energy shareholders. "Noble's high-quality assets complement Chevron's advantaged upstream portfolio, and the combination is expected to deliver strong financial benefits," said Chevron Chairman and CEO Michael Wirth. "With an industry-leading balance sheet and a track record of capital discipline, we believe we're in a different place than others and can protect the dividend while driving long-term value."

**Oct. 28, 2020** - The Board of Directors of Chevron Corporation declared a quarterly dividend of one dollar and twenty-nine cents (\$1.29) per share, payable December 10, 2020, to all holders of common stock as shown on the transfer records of the Corporation at the close of business November 18, 2020.

#### **Chevron Announces Third Quarter 2020 Results**

- Third quarter loss of \$207 million; adjusted earnings of \$201 million
- Capital spending down 48 percent; operating expenses down 12 percent
- Noble Energy acquisition completed in October 2020

**Oct. 30, 2020** - Chevron Corporation today reported a loss of \$207 million (\$(0.12) per share - diluted) for third quarter 2020, compared with earnings of \$2.6 billion (\$1.36 per share - diluted) in third quarter 2019. Included in the current quarter was a charge of \$130 million attributable to a tax item related to an international upstream end-of-contract settlement and a non-cash provision of \$90 million for remediation of a former mining asset. Foreign currency effects decreased earnings by \$188 million.

Adjusted earnings of \$201 million (\$0.11 per share - diluted) in third quarter 2020 compares to adjusted earnings of \$2.9 billion (\$1.55 per share - diluted) in third quarter 2019. Sales and other operating revenues in third quarter 2020 were \$24 billion, compared to \$35 billion in the year-ago period.

## **VOLUNTEERING OPPORTUNITIES WITH CHEVRON HUMANKIND**

The pandemic is still shutting down a lot of our normal avenues for volunteering. Here are a few that I would like to highlight that are looking for volunteers:

**Bay Area Crisis Nursery**: Many of you probably volunteered through Chevron Humankind at BACN as the relationship between Chevron and BACN has been going on a long time. BACN is looking for someone to join their Board of Directors. Here is a chance to use all those skills that you honed at Chevron to help a great Community Partner. The Bay Area Crisis Nursery was established to help prevent child abuse and neglect by providing supportive services to families. Their primary service is providing a warm, loving, homelike environment for children from birth through 5 years of age by offering 24-hour care and emergency childcare services. **EnCorps**: Last year, EnCorps STEM Fellows, all former industry professionals, impacted over 60,000 students by becoming educators in high needs middle or high schools. This year, we want to further our impact in public education by introducing a new virtual volunteer tutoring opportunity. We are piloting a STEMx Math Tutoring program where students would be paired with a tutor for 2 one on one sessions a week. **Richmond Promise**: Launched in January 2016, the Richmond Promise is a community-wide college success initiative to build a college graduating culture in Richmond, CA. The Richmond Promise was created with the belief that all Richmond students should have the opportunity to develop their skills and reach their full potential, regard-less of race, income level, or personal background. Career Mentorship: This mentoring program is designed for professionals to share knowledge, skills, best practices, and perspective to foster the personal and professional growth of our Scholars. **United Way of the Bay Area**: In partnership with United Way Bay Area and SparkPoint Contra Costa, share best practices when it comes to resumes and interviews! SparkPoint's mission is to empower individuals and families to become financially sustainable and advocates for social change. Resume Tips: Volunteers are matched one-to-one with attendees to edit, revise, and share a United Way Bay Area template resume. Volunteers are also asked to share their professional resumes for examples of styles for various industries. Interview Practice: Volunteers will share experiences with participants interested in their career field for a Q&A about interview best practices, career paths, industry insights, and other topics.
