## SCHOLARSHIP PROGRAM 2022-2023

Our Contra Costa Chevron Retirees Chapter has initiated the start of the 2022-2023 Scholarship Program with the current newsletter and the dues notice that is included in it. Thanks to the generous donations of our members, we have had a very successful scholarship program, distributing over \$112,000 to 73 students since 2005. Prior to the 2021-2022 program, we had an outside organization administering the program. We now have a chapter Scholarship Committee with internal and external judges evaluating the scholarship applications.

We suggest that you encourage your children, grandchildren, or great-grandchildren to apply for one of the scholarships. We anticipate awarding four scholarships for \$2000 each, but this will depend on your generous donations to the program. The scholarship application is available on our chapter website. The deadline for the scholarship submission is May 15, 2022.

Students may apply each year they are eligible, but those who have previously been awarded a scholarship by our organization are not eligible to reapply. The criteria for eligibility are:

- Be a child, grandchild or great grandchild of a dues paying member of the chapter.
- Be age 25 and under.
- Be enrolled, or plan to be enrolled, in the coming school year in a full-time undergraduate course of study at an accredited two or four-year college or university.

## IMPORTANT UPDATE ON COVID-19 VACCINE BOOSTER SHOTS

Good news! If you're 18 or older and you're fully vaccinated for COVID-19, you can get a COVID-19 vaccine booster shot. Booster shots are now available for the Pfizer, Moderna, and Johnson & Johnson COVID-19 vaccines. You can get a booster shot at least 6 months after you complete your second dose of the Pfizer or Moderna vaccine. Or, you can get a booster shot of the Johnson & Johnson vaccine at least 2 months after your first dose. The booster shot can help strengthen and prolong your protection against COVID-19. Visit CDC.gov or contact your medical plan or primary care physician for more information. Remember: The COVID-19 vaccine booster shot is no cost to you.

## PUBLIC SERVICE AWARDS

Our own Debbie Jones received one of the two Public Service Awards given out by Chevron to retirees at our Annual Meeting. Debbie retired in 2016 and started volunteering at Tracy Interfaith Ministries (www.tracyinterfaith.org) that same year. Tracy Interfaith Ministries started in 1988 and services the low-income residents who live within the Tracy Unified School District and Lammersville School District and also help those stranded in Tracy. They always provide some food even when they must refer some clients to another town for help. No one leaves their premises hungry.

In Debbie's words: "Tracy Interfaith Ministries is a faith-based organization with support from 22 churches. We require nothing more than evidence of need from our clients. In addition to food and clothing, we provide many other essentials such as shampoo and toothpaste, and in some instances, we provide emergency bus tickets, plus referrals to other service organizations. Annually we serve about 36,000 clients, receive donations of about 500,000 pounds of food (not including the food we purchase), and receive donations of about 300,000 pounds of clothing. I started off working in the pantry and warehouse, receiving food donations, stocking shelves and filling food orders for clients. Then, suddenly out of the blue, the Treasurer died at the end of 2017. The Assistant Director there knew my background and I was asked to step into the role of Treasurer. I've been doing that role ever since and for the most part I continued my work in the warehouse and pantry – with a partial break last year when I had some health issues. But, I've steadfastly done all their bookkeeping requirements, handled all their audits, worked with their CPAs and made sure all the tax filings were completed. Just recently, the Director and I were able to obtain a Sales Tax Exemption for items we purchase and hand out to our clients (things like toothpaste, toothbrushes, laundry soap, and dish soap).

Tracy Interfaith Ministries has been long established in Tracy and are very much supported by the Tracy community. As an example of this support, the City leases them the land their building is located on at \$1 a year for 50 years. They provide food and clothing free of charge to low income individuals and families. I use my volunteer hours to obtain the Chevron Grant and Chevron matches my donations to this organization. Up until this point, it has been an entirely volunteer run organization. However, last week, our Board of Directors voted to start paying our Director. This responsibility for setting up the payroll will fall on me. Thankfully, I have the support of the Board to outsource this (which is the recommendation of our CPA firm). I am very happy that I am able to use the skills I learned at Chevron to contribute to this organization. It does help keep my mind sharp and I know how much Tracy Interfaith appreciates the work I do for them – they thank me ALL the time"

Debbie retired in 2016 after 36 years of service, mostly in the Tax Department.
